# 2. OUR ORGANIZATION

#### • An agile and functional organisation

AMETIC is organised around **19 Commissions**, which meet the needs of our Partners. Each commission covers a number of subjects belonging to the same ecosystem.

#### An efficient organisational structure

In a sector as changing and dynamic as the digital one, efficiency and speed are the key to success. Our organisational structure is matricial and flat, with goal-oriented management and always maintaining the association's strategic vision.

Our employees are a critical component in achieving our partnership goals. That is why we promote continuous learning, a commitment to excellence and internal communication channels.

#### New forms of participation in the Association

In addition to the full member, there is the 'Associate Member'. According to our Articles of Association, these may be companies, organisations and non-governmental institutions that do not carry out their own activities but wish to join because of their specific interest in some of AMETIC's activities; or other organisations as decided by the Board of Directors. These affiliated members will have right to speak but not to vote.

#### Representativeness and transparency

With regard to members' voting rights, AMETIC has a system which, while retaining the "one company, one vote" system, grants weighted representation on the Board of Directors, by group according to the size of the companies, as well as the direct presence of all the commission chairmen. With this organisation, a balanced presence of all sizes and interests is ensured, maintaining the principle of representation by election among the members.
